Recruitment of Research Officer (Homoeopathy)

Applications are invited from eligible candidates for filling up of 16 (sixteen) posts of Research Officer (Homoeopathy) as per following details: -

Age Limit:	Note exceeding 40 years
Educational and other qualifications:	(i). M.D. in Homoeopathy from a recognized Statutory Board/ Council/ University included in the Second Schedule to Homoeopathy Central Council Act, 1973. (ii). Enrolment on the Central Register of CCH or State register of Homoeopathy.

Research Officer (H)

Applications are invited from eligible candidates for filling up of the post of Research Officer (Homoeopathy) in the Units/Institutes of the Central Council for Research in Homoeopathy. Qualifications and other eligibility conditions are given below:

No. of post (s):	16 (Sixteen) [Group-A] (Unreserved- 09, SC-02, OBC- 04, EWS-01) [One post is reserved for physically handicapped candidate.] (The posts are suitable for Orthopedically Handicapped persons with One leg or one arm affected).
Level in the Pay Matrix:	Level-10+NPA [PB-3 Rs. 15600-39100+Grade Pay Rs.5400/-+NPA as per 6 th CPC]
Age Limit:	Not exceeding 40 years (Relaxable for Government Servants in accordance with the instructions or orders issued by the Central Government).
Educational and other Qualifications:	(i) M.D. in Homoeopathy from a recognized Statutory Board/Council/University included in the Second Schedule to the Homoeopathy Central Council Act, 1973. (ii) Enrolment on the Central Register of CCH or State Register of Homoeopathy.
Duties:	To undertake research in the field of Homoeopathy and assist the Council in the administration, planning and execution of research programmes and other activities of the Council.

GENERAL CONDITIONS:

1. **The last date for receipt of application is 9th April, 2019.** The application received after the last date OR without requisite fee will be summarily rejected and no correspondence in this regard will be entertained. If the last date happens to be a holiday, it will stand extended to the next working day.
2. The competent authority reserves the right to extend the closing date for receipt of applications and also reserves the right to postpone/cancel the recruitment exercise for the post at any stage of recruitment.
3. The candidates are required to pay the following fee:

General, OBC and EWS	Women/SC/ST/Physically handicapped
Rs. 1000/- (one thousand).	Nil

Fee is to be paid in the form of Demand Draft or Pay Order, to be drawn in favour of 'Director General, CCRH' and payable at New Delhi. Fees once paid will not be refunded nor adjusted in future recruitment. Applications received without requisite fee will be summarily rejected.

4. **Eligibility** of the candidate including maximum age limit will be counted as on the closing date.
5. **Application Form and Documents:** Self-attested copies of the following documents are required to be submitted along with the Application Form:

- a. **Application:** The application should be in the prescribed format (**Annex-1**) duly completed in all respects and all pages, including enclosures, signed and continuously numbered.
 - b. **Proof of Age:** Matriculation/10th Standard or equivalent certificate indicating Date of Birth or Mark-sheet of Matriculation/10th Standard or equivalent issued by Central/State Board indicating Date of Birth.
 - c. **Educational qualifications** (Mark-sheets and degree certificates), of both BHMS and MD(H);
 - d. **Registration certificate** issued by the State Board of Homoeopathy or Central Council of Homoeopathy.
 - e. **Caste/Community/Tribe/EWS** certificate as per the formats prescribed by the Department of Personnel and Training, Government of India for employment under the Central Government – specimen forms are enclosed (**Annex-3-6**). OBC certificate should have been issued within last 03 years.
 - f. **Physically handicapped** candidates are required to submit certificate in the prescribed format from the competent medical authority indicating the degree of physical disability as 40% or more.
 - g. **Application fee:** Should mention the relevant details in the application form. The DD/Pay order should be properly attached on the front page of Application form. Further the candidate should write his name, address and telephone number on the back of the DD/Pay order.
 - h. **Experience:** Experience indicated by the candidate in the Application Form should be supported by certificates from the concerned institutions.
 - i. Original certificates are required to be produced at the time of interview.
6. The applications in the prescribed format, duly completed in all respects, should reach the **Director General, Central Council for Research in Homoeopathy, 61-65, Institutional Area, Opposite D-Block, Janakpuri, New Delhi-110058** by the prescribed closing date. The Candidates should also fill up the relevant columns of Admission Ticket (**Annex-2**) and submit the same alongwith the application form. The candidates should mention “**Application for the post of Research Officer (H)**” in bold letters on top of the envelop.
7. Age relaxation to candidates belonging to SC/OBC (as per Central List of OBCs)/PH etc. will be available as per the orders of the Government of India. Specimen forms are enclosed (**Annex-3 to 4**). Further, the candidates belonging to OBC category (non-creamy layer) may also submit a declaration as per proforma in **Annex-6**.
8. The upper age limit is relaxable for Government servants as per Government of India (DoPT) orders. A candidate seeking age relaxation under this category would have to produce a certificate issued after the date of advertisement from his/her employer on the office letter head as per the proforma attached (**Annex-7**). The age relaxation will be admissible to such Government servants as are working in post which are in the same line or allied cadres and where a relationship could be established that his service already rendered in a particular post will be useful for the efficient discharge of the duties of the post the recruitment of which has been advertised.

SELECTION PROCEDURE

9. Selection will be made through a written test and interview.
10. **Multiple Choice Questions Paper** will comprise 150 (One hundred fifty) Multiple Choice Questions (MCQs) – 01 mark for each question and will be of 02 (two) hours duration. There

will be negative marking (0.25) for wrong answer. The language of the Questions will be English only.

11. **Multiple Choice Questions** will comprise questions covering the following subjects: All the subjects under BHMS and common subjects of MD (H), namely, Research Methodology, Research updates and Bio-statistics. A candidate will be required to indicate the best possible option, out of the suggested options, in the given scenario.

12. **Interview:** This will comprise 30 (thirty) marks.

SCHEDULE OF WRITTEN TEST:

13. Details of the date and venue of test and interview will be notified later on.

INTERVIEW:

14. Based on the performance in MCQ Test paper, the candidates in the ratio of 1:3, subject to meeting the cut-off criteria as mentioned in para 15, in each category, will be invited for interview.

CUT-OFF MARKS:

15. While making the final list, cut-off marks will be applied for written test and interview separately, that is, a candidate will have to secure the minimum cut-off marks in the written test and Interview to be considered for inclusion in the select list or reserve panel. The cut-off marks will be as under:

SC/PH	40%

However, the competent authority reserves the right to fix a lower cut-off mark in case of SC/PH for the written test and interview in case the candidates meeting the prescribed cut-off marks are not available to fill up the posts reserved for them.

MISCELLANEOUS:

16. A provisional examination of the application will be made and details of such examination will be made available to the candidate. An opportunity will be given to the candidates to represent against rejection of their application.

17. At the time of Interview, the candidates will be required to produce all the original documents for verification and No Objection Certificate form their employer. **Failure to produce original documents/NOC will render the candidate's ineligible to appear for the interview.**

18. The number of vacancies may vary subject to the requirement at the stage of final selection.

19. The jurisdiction for all legal matters for this recruitment will be exclusively at New Delhi and legal cases filed (if any) in other courts will not be maintainable.


20. Council will not be held responsible for any postal delay.

21. Candidates are requested to see Council's website (www.ccrhindia.nic.in) on regular basis for any new announcement in this regard. Any new announcement will be made only through

the website of the Council. Candidates are advised to indicate an e-mail ID's in their application and keep it active.

22. The appointment will be subject to medical examination and verification of character and antecedents of the candidates from the competent authorities.
23. The selected candidates will be governed by the Rules and Regulations as are applicable to other employees of the Council and necessary undertaking will have to be given before appointment.
24. New Pension Scheme (NPS) 2004 will be applicable.
25. The individuals selected against the above vacancies will be posted in any of the Institute/Units of the Council. When posted in a teaching institute under the Council, the candidate will be assigned teaching responsibilities and designated accordingly. The exact place of posting will be decided after the selection is finalized. The Institute/Units of the Council are located throughout India and the details are available on the website of the Council.
26. The Candidates selected for appointment are liable to be transferred anywhere in India.
27. No TA/DA will be admissible for attending written test and Interview.
28. **Canvassing through any source will lead to disqualification of the concerned candidate.**
