



Best Regards, Dr.Tapas Kumar Kundu Abstract for the conference on Integrative Medicine – Roadmap for Homoeopathy based on the research experience in Haemophilia.

Haemophilia is a rare genetic bleeding disorder associated with uncontrolled bleeding following a minor trauma to a massive fatal haemorrhagic episode. These patients are treated with deficient factors concentrates, Pain killers like Paracetamol, Tramadol & Anti Fibrinolytic Drugs like Tranexamic Acid, etc. in India and thus could reach 17,346 out of estimated 1,30,000 (World Federation Of Haemophilia, Global Survey 2015). In spite of providing the best possible treatment to the PWH, still there is limitation in the complete and comprehensive management and reaching to all the PWH of India which are otherwise addressed fully in other developed countries of the west.

India is a country ornamented with various alternative and complementary therapies as advocated by the ministry of AYUSH, Govt. of India. Based on this heritage and culture in 21st of December 2007 the camps of Homoeopathy in Haemophilia started and it has been more than plus 12 years of age to these charitable camps. The cases included haemophilia A, Haemophilia B as common presentations but during this journey we came across many other rare bleeding disorders associated with other factor deficiencies such as Glanzmanns Thrombesthenia, Afibrinogenemia, Factor XIII deficiency, Von Willebrand Disease, combinations of these factor deficiencies and other associated Genetic diseases etc.

The success in managing acute hemorrhagic episodes and the chronic symptoms led to formation of multicentre across Maharashtra and Gujarat. These centers are efficiently managed by all our post graduate students trained at Nashik Homoeopathy in Haemophilia centre. Currently the centres actively working are Mumbai, Nagpur, Amravati, Dhule, Surat and the Nashik centre in collaboration with CCRH and Motiwala Homoeopathic Medical College. This all started when the then Director of NIIH, KEM Mumbai Dr. Kanjaksha Ghosh collaborated with Homoeopathy in Haemophilia as he was in search of an alternative therapy like homoeopathy with his much knowledge regarding both the subjects i.e Haemophilia and Homoeopathy.

The results were quite sufficient enough as evidence to the scientific community and therefore got published through our various articles. Previously only treatment available was plasma therapy and cryoprecipitate which brought with itself other transfusion related disorders. This was the reason people were more interested in seeking for alternative therapy like Homoeopathy for treatment of haemophilia. Homoeopathy being a individualistic science had much in store to offer such patients. As with advancements factor replacement therapy started but again it came with it own hazard of inhibitors. On the other hand it was quite costly as compared to homoeopathic treatment which is naturally a cost effective treatment with substantial relief to the patient.

Side by side of the regular monthly camps and emergency management, HIH team could publish various articles to address the myths of Homoeopathy and also to quench the thirst of researchers namely:

Homeopathic medicines substantially reduce the need for clotting factor concentrates in haemophilia patients: results of a blinded placebo controlled cross over trial

Results: 28 patients were recruited. Homeopathic medicines improved frequency of bleeding, extent of bleeding, blood products consumed and pain scores (P < 0.0001). There was also significant improvement in well being. Plasma levels of clotting factors did not change. No patients developed inhibitors during the study there were no dropouts.

2) Management of Acute Bleeding in Severe Haemophilia Using Homeopathic Medicines: a Multicentric Case Series

Results: Four hundred and ninety four severely affected PWH from Nashik (292), Mumbai (182) and Surat (20) presented with 636 episodes of bleeding. Five hundred and seventy eight bleeding episodes (91%) were success fully managed with homeopathic medicines only. In 21 episodes (3.1%) homeopathic medicines failed but responded to additional factor concentrates. 37 patients who received factor concentrates without any apparent benefit in the given time responded to homeopathic medicines. Out of 31 patients who bleed with inhibitor (2.4–6.7 BU/ ml) but 23 of these patient responded (65%) to homeopathic medicines. The inter prescriber correlation on the class of medicine prescribed by three homeopathic physicians was substantial (Fleiss kappa of 0.67).Pain relief in these patients were also substantial (87/105 i.e., 83% patient with acute Haemarthrosis). Single patient of severe factor XIII deficient who continuously bleed from umbilical stump responded to abrotanum 30.

An Exploratory Study of Autonomic Function Investigations in Hemophiliacs on Homoeopathy Medications Using Impedance Plethysmography

Conclusions: Haemophiliacs were shown to have higher autonomic activity as compared with healthy controls. Homoeopathic medicines used as an adjunct was associated with decrease in parasympathetic modulations.

Homeopathic Medicine Reduces Pain and Hemarthrosis in Moderate and Severe Hemophilia: A Multicentric Study

Results: 1,679 episodes of hemarthrosis in major joints were encountered between December 2007 and March 2014, in 343 patients. In 1,580 of the 1,679 hemarthrosis episodes (94.1%), bleeding/inflammation was arrested and pain relieved with homeopathic medication. Additional factor concentrate was required in 99 patients (4.48%). The mean pain score improved from 6.88 ± 2.118 to 1.5 ± 0.34 over 6–24 h following the homeopathic medicines (p < 0.0001). The swellings were also substantially reduced (p < 0.001). The number of joint bleeds per month was reduced significantly under the influence of therapy (p < 0.0001), showing the long-term disease-modifying effect of the treatment.

Add on homoeopathic management of a scrotal hematocele in a diagnosed severe haemophilia patient: Evidence based case report

Conclusion: On the basis of symptom similarity and acute totality of this case, Arnica Montana 200 along with Standard Factor Management can efficiently manage scrotal hematocele in severe haemophilia patient.

6) Homoeopathic Management of a Case of Severe Haemophilia Type A with Inhibitor Positive: Case Report

Conclusion: Homoeopathic medicines proved to be useful not only in managing the acute bleeding episodes but also in improving the overall quality of life of the haemophilia patient. The medicines also helped in reducing the inhibitor titre levels from 4 BU/mL to 2.1 BU/mL. Also, homoeopathic treatment could considerably reduce the out-of-pocket expenditure among patients and their families.

Proposition – After working with genetic diseases for quite long time we have identified a different class of bleeders may also be termed as Silent bleeders. If we consider Indian population approximately 130 crore of which 65 crore are females. Of which, 30% of the females are in reproductive age group, of which 10% are heavy bleeders and due to their long term and protracted menses they suffer from anaemia. They are given various empirical treatments whatever be the underlying cause which remains obscured. Some of these patients when not responding to these therapies have to lose their uterus on hysterectomy. Institutions like ICMR immunohematology would be of immense help in diagnosing and genetic study of such cases. This can help in proper symptomatic relief of such a large group of neglected people through an interdisciplinary collaboration of a gynaecologist, haematologist, genecist and a homoeopath. This would pave the way of ray of hope for such Silent Bleeders.

In the present decade Middle East respiratory syndrome (MERS) is a viral respiratory disease caused by a novel corona virus (Middle East respiratory syndrome corona virus, or MERS-CoV) that was first identified in Saudi Arabia in 2012. Coronaviruses are a large family of viruses that can cause diseases ranging from the common cold to Severe Acute Respiratory Syndrome (SARS).

As per the Indian National Cadet Corps Red Cross Society & the Ministry of AYUSH. In January 2020 the World Health Organization (WHO) declared the outbreak of a new corona virus disease in Hubei Province, China to be a Public Health Emergency of International Concern. Since then WHO has declared it as a

Pandemic affecting more than 115 countries around the globe. India has seen its first COVID-19 case in Kerala on 30th January 2020.

Infectivity and fatality rate - infectivity is very high and 3.4% Mortality Rate estimate by the World Health Organization (WHO) as of March 3

Homoeopathic back ground of epidemics and COVID 19 pandemics-

In present scenario there is no specified vaccine for COVID 19 is available. Though there are various organizations utilizing their knowledge and resources to find a breakthrough.

In Homoeopathy at the onset of epidemic different opinions about Genus Epidemicus arrived. Homoeopathic Medicines namely Arsenic Album, Camphor, Bryonia, Calcare Carb, Zincum Mur and some nosodes like Influenzinum, Pneumococcin in view of public concern. The logic behind the selections of medicines is highly adorable and somewhat guided by the master Hahnemann's writing and doctrines as mentioned in Homoeopathic Materia Medica.

As per Scientific Advisory Board of the Council-

On the other hand Homoeopathy has proven its role during outbreaks of various epidemics. The 'genus epidemics' has been described by Dr. Samuel Hahnemann in his Organon of Medicine.¹

The Scientific Advisory Board of the Council in meeting held on 28.1.2020 discussed to find out possible genus epidemicus for recent outbreak of COVID 16 through the common signs and symptoms of the patients from the clinical history of patients of Wuhan, China in Lancet titled, "Clinical features of patients infected with 2019 novel corona virus in Wuhan, China".²⁰

Scientific Advisory Board considered that the same medicine has been advised for prevention of Influenza like Illness^{21, 22, 23}. In one of the studies Arsenic album as one of the constituents in a formulation affected HT29 cells and human macrophages. Also, it showed 1NF-κB hyperactivity (reduced expression of reporter gene GFP in transected HT29 cells), 1TNF-α release in macrophages.²⁴ More over Arsenic album is a common prescription in the cases of respiratory infections in day to day practice. *Arsenic album* 30C could be advised as Genus Epidemicus as preventive against Corona virus infection Keeping in view the positive results from the genus epidemicus as prophylactic during epidemic outbreaks of various diseases during recent past

As per advisory of AYUSH Annexure I-

The preventive aspect of Homoeopathy is well known, and historically. Homoeopathy has reportedly , been used for prevention during the epidemics of Cholera, Spanish influenza, yellowfever, Scarlet fever, Diphtheria, Typhoid etc. The genus epidemicus (GE) is the remedy found to be most effective for a particular epidemic once data have been gathered from Several cases, it was reported that, during recent past GE had been used during various disease outbreak for preventig the spreading of diseases like Chikungunya, Dengue

Fever, Japanese Encephalitis and cholera with good results As detail accounts of use of homoeopathy in control of epidemics are given in recent publications. Lot many organizations are developing vaccine for COVID 19. But it is at experimental level. There efficacy has not yet proved. Some antibacterial and anti-malarial drugs are showing the hope of light still they cannot be considered as a standard line of management. Further no specific anti-viral chemoprophylaxis is available. During Ebola outbreak in 2014 expert group of WHO has recommended that "it is ethical to offer unproven interventions with as yet unknown efficacy and adverse effects, as potential treatment or prevention" keeping in view no vaccine or anti-viral were available.

As per demand of people for improving immunity, we at MHMC has already distributed the CCRH recommended Ars. Alb 30 in an apparently healthy population nearly 15000 in Nashik city.

The follow ups will be conducted prospectively to identify the subsequent positive or negative assessment. People however should also follow general measures as per health advisory above.

Based on the present scenario we wanted to intervene with:

Primary Objective- Homoeopathic prophylaxis Arsenic Album in 30 potency in three consecutive doses in three successive mornings and repeated after month.

Secondary objective - Improvement in others symptoms (Except COVID and flu like classified symptoms) and quality of Life (QOL both mental and physical) Materials and Methods-

Motiwala Homoeopathic Medical College and Hospital and F.G. Motiwala P.G. Institute of Homoeopathy & Research Centre, Nasik after due sanction from ethical permission from institutional ethical committee would like to proceed for providing general homoeopathic prophylaxis to the persons in phase of COVID 19 visiting out patient department of Motiwala Homoeopathic Medical College or health check up camps and surveillance. Another group we will consider the contact with COVID 19 case if available.

Outcome will be evaluated after a fortnight (15days) for immediate effect and again after a month for the remote effect.

The practice of Yogasana and Pranayama under the guidance of qualified Yoga instructor is recommended.

Common medicinal plants useful in similar symptoms are Tulsi (Ocimum sanctum), Gudchi (Tinospora cordifolia), Ginger (Zingiber officinale) and Turmeric (Curcuma longa).

It is mandatory to obtain patients declaration from the patient counter signed by any of his/her family member before providing standalone Homoeopathic Treatment Protocol.

In case of any adverse condition arisen, they should communicate the issue to the chairman of the ethics committee immediately.

Sir,

The Motiwala Homoeopathic Medical College has been an active warrior in our battle against COVID-19 right from 25th March 2020. Where we were active in providing Homoeopathy as a Prophylaxis and an Immunity Booster. This work of Motiwala College proved its efficiency in the Police Force of Nashik and the Police Commissioner gave a letter praising the use of Arsenicum Album-30, which led to our team been permitted to by the Municipal Commissioner to not only distribute Homoeopathic medicines in Malegaon but also apply the CCRH protocol to the 3 Quarantine Centers, as well as treat the COVID-19 patients at one of the Secondary COVID-19 Care Center (for COVID-19 active cases).

It would be interesting to refer to our letter to your office from the Motiwala Homoeopathic Medical College and Hospital, Nashik dated 10/06/2020 ref no. MHMC/COVID-19/228/2020. When Motiwala Homoeopathic Medical College started its activity in Malegaon on 4/5/2020. The Doubling rate of COVID-19 in Malegaon as on 2nd May 2020 was 5.7 days. The death rate per day was 55 patients. After the Mass distribution of Homoeo-Prophylaxis to the population of Malegaon which started on 14/5/2020. {Prior to these 3 Homoeopaths had distributed medicine to 10,000 to 15,000 persons approximately}, from 14/5/2020 to 20/5/2020 MHMC College had distributed 106040, bottles of Arsenicum album 30, one bottle provided medicine for 5 members of a family for 3 days as per the protocol of CCRH New Delhi and that comes to 530200, persons which is all documented. From 17th May 2020 after special permission from the Commissioner of Malegaon we started providing the Quarantine Protocol to 115 persons, which has been well documented. At the same time one team treated 35, COVID-19 Active patients at the Farhan Hospital. All this resulted in Malegaon's doubling rate GACOVID 19 CORVID 1

becoming amongst the best in Maharashtra at 56 days on 10/6/2020 and death rate which had risen to 54-56 deaths per day in the beginning of May 2020, was brought down to 9-10 deaths per day which is even lower than the 2 years average before onset of COVID-19 which was 14-16 deaths per days.

Based on these results, experience and learning that has been documented has resulted in formulating a 'Protocol' for the treatment of COVID-19 Active cases and this protocol is reconfirmed from the learning that has come from the work done by the Neminath Jain Homoeopathic Medical College, Agra.

The Motiwala Homoeopathic Medical College's Hospital is a registered hospital for COVID-19 treatment centre and has been put in action from 20th June 2020.

During the past one week we have faced a 7-8 cases that had some or the other Side Effects and intolerance to allopathic medicines and even refused to take them. After taking an undertaking from the patient our team has used Homoeopathy as a standalone therapy under the supervision and monitoring of a medical expert who is an Allopathic M.D. Physician. The results were found to be very satisfactory.

Based on this experience and learning, there has been a demand for standalone Homoeopathic Treatment which we only do when the adverse reactions, side effects and over all general condition justify the holding back of the suggested allopathic medicines and only after the confirmation of the Medical Expert who is an M.D. Physician of the allopathic science.

In the light of the above we request you to kindly allow us the use of Homoeopathy as a standalone therapy under the guidance, supervision and monitoring of an Medical Expert from the Conventional (Modern Medicine), so that the efficacy and reliance of Homoeopathy may be studied further.

Approval from our Institutional Ethical Committee has been taken and its guidelines shall be followed meticulously.
