Standard Operating Procedure

Constitution of Committee:

- The purpose of the IEC is to protect human subjects through ensuring highest ethical standards and conduct in all research carried out under the auspices of MHMC.
- The committee is headed by Chairperson and Six other members including person from basic medical science, clinician, social scientist, philosopher, lay person from the community, and member secretary.
- 3. As recommended in the Indian Council of Medical Research (ICMR) guidelines, the basic responsibility of the IEC is "to ensure a competent review of all ethical aspects of the project proposals received by it in an objective manner" (ICMR 2006, p 8). Guided by the recommendations of the ICMR, the IEC of MHMC endeavors to protect and promote the dignity, rights and wellbeing of potential research participants; ensure that universal ethical values and international scientific standards are adhered to and contextualized to suit the local context; to advise, educate and train the MHMC research community periodically; and to apprise its ethics committee member on any updates.
- IEC of MHMC under ordinary circumstances will meet twice in a year. It may convene a meeting to discuss any ethical issue that may deem necessary.

Duties and responsibilities:

- The committee works as per the vision and mission of the college to promote the best academic atmosphere conducive to the learning objective of the students and to create competent research oriented Homoeopathic physicians.
- The committee will encourage faculty, Postgraduate scholars, Interns and students to take up research in Homoeopathy.
- 7. Invite proposals, review about ethical issues
- 8. Issue ethical clearance to the research proposals after review.
- 9. To provide necessary guidance and logistics required to conduct research
- 10. To facilitate promotion and publication of research conducted in MHMC.
